


# Did Your Job as a Firefighter Expose You to Asbestos?



Some former firefighters may have considered asbestos an ally in fighting fires. Asbestos, a naturally occurring mineral, is non-flammable and prior to 1980, it was used in many different products to aid in fire resistance. From insulation to roofing materials, asbestos-containing products could be found throughout commercial and residential buildings in the U.S.

- Unfortunately, when asbestos-containing products are disturbed or damaged—like in a fire—tiny, needle-like fibers can be released into the air and inhaled by anyone close by. Inhalation of those asbestos fibers is what causes mesothelioma, a deadly cancer.
- There are a number of different ways in which firefighters may have been exposed to asbestos. Fighting fires at residential homes is a common source of exposure, but some firefighters could have battled blazes occurring in commercial or industrial areas. Industrial firefighters may have run into burning petrochemical facilities, shipyards, or manufacturing plants—all buildings which could have been built with asbestos-containing materials like floor tiles or insulation. The same buildings may have also been filled with asbestos-containing products that were used in day-to-day operations like heavy machinery or hand tools. In the past, even some of the protective gear that firefighters wore to shield themselves from flame and heat was made with asbestos-containing materials.
