5 SIMPLE STEPS TO FILE YOUR CLAIM:

1 Phone Consultation

Initially, you will speak with a mesothelioma case manager, who will determine whether you are eligible for a potential claim. You may be asked such questions as:

- Who was diagnosed, when, and with what asbestos-related disease?
- What is the victim's work history? Was he or she ever in the military?
- Has anyone else in your family ever worked around asbestos?

Your case manager will then assess the information to determine the appropriate next steps for your potential claim.



2 In-Person Visit

If you qualify during the initial phone call, we will come to you — and can often be there the next day — to answer any questions you might have. We will help guide you through the documents to be signed, including medical, Social Security, and military authorization forms. We will meet with you at no cost to you — at your home or another location of your choosing and at your convenience. We will also explain the fee agreement. It is important for you to know that your mesothelioma lawyer is compensated only if you receive money from your claim.

3 Investigation

Following the in-person visit and after the initial paperwork is completed, your claim will be assigned to a legal team tailored to your specific case. The team of mesothelioma lawyers, paralegals, investigators, and other staff will typically schedule an introduction with you within 3 to 10 days of receiving your claim.



Once you have been introduced, the team will begin investigating the details of your mesothelioma claim. They will evaluate your medical records, collect witnesses, and, if appropriate, retain experts to provide further review of medical documents. They will also look into the asbestos-containing products that may have caused the disease.

4 Filing Your Claim

Your claim will be filed when your legal team has confirmed your mesothelioma diagnosis and believes they have identified the asbestos-containing products that may have caused the disease. They will file a claim on your behalf while continuing to build supporting evidence. In some cases, you may be asked to give your testimony. Should this be necessary, your legal team will meet you at a time and location convenient for you to take your testimony. Very rarely does this testimony take place in court.



5 Results and Outcome

It is extremely rare for mesothelioma cases to go to trial. With an estimated \$30 Billion available in court-ordered trust money, a settlement will likely be offered if your claim qualifies for compensation. Your team will advise you of the money offered and sign off only once you have agreed to the terms of the settlement.
