Zantac and the NDMA Problem:

Isolated Event or Tip of the Iceberg?

In this fast-paced, fast-food world we inhabit, you don't have to go far to find someone who takes a prescription drug to treat hypertension or who regularly pops an over-the-counter product to alleviate heartburn. Among the most commonly prescribed drugs in the U.S., these medications account for millions of prescriptions and billions of dollars in sales annually.

Naturally, consumers and healthcare providers alike were alarmed over recent drug recalls triggered by the presence of the cancer-causing chemical N-Nitrosodimethylamine (NDMA). NDMA-associated recalls involving the blood pressure medication valsartan and the popular antacid drug Zantac®, have led to the filing of hundreds of lawsuits by those who claim to have developed cancer, or have been otherwise harmed from the use of these products. Given the severity of the alleged injuries, the question on the minds of many is whether these recalls are isolated incidents or a harbinger of more to come.

NDMA in Drug Products

NDMA is a semi-volatile organic chemical that forms in both industrial and natural processes. It is a member of a family of potent carcinogens called N-nitrosamines. Though NDMA is no longer used commercially in the U.S., it was formerly used in various applications including the production of liquid rocket fuel. Both the Environmental Protection Agency (EPA) and the International Agency for Research on Cancer (IARC) have classified NDMA as a probable human carcinogen.

The U.S. Food and Drug Administration (FDA) maintains that everyone is exposed



to some level of NDMA, a common contaminant in water and foods like cured and grilled meats. However, it acknowledges that nitrosamine impurities may increase the risk of cancer if exposure is above acceptable levels and over long periods of time. A drug found to contain NDMA above the FDA's acceptable daily intake limits may be subject to recall. According to the agency, the source of NDMA in a drug product can be related to the manufacturing process or its chemical structure or even the conditions in which it is stored or packaged.

Excessive Levels of NDMA in Zantac

Ranitidine, better known as Zantac, is an H2 (histamine-2) blocker that works by lowering the amount of acid created by the stomach. Available either over-the-counter (OTC) or by prescription, it has been used by millions of people to treat gastrointestinal issues including gastric ulcers, gastroesophageal reflux disease (GERD), and heartburn.

In a 2019 Citizen Petition, the online pharmacy Valisure called on the FDA to protect the public and request the immediate recall of all ranitidine products from the market. Results from Valisure's own testing detected "extremely high levels" of NDMA in every lot of ranitidine it tested, across multiple manufacturers and dosage forms – far in excess of the FDA's permissible daily intake limit of 96 nanograms. It attributed the formation of NDMA to an "inherent instability of the ranitidine molecule." The drug itself may metabolize to form NDMA.

Zantac Off the Market

A September 2019 FDA warning about the potential risks of NDMA in Zantac products followed, setting off a cascade of voluntary recalls, culminating in the FDA's April 2020 request for the immediate market removal of all prescription and OTC ranitidine products. FDA had determined that NDMA levels in some ranitidine products "increase over time when stored at higher than room temperature," which may result in consumer exposure to unacceptable levels.

The agency was already investigating the presence of NDMA in valsartan, an Angiotensin II Receptor Blockers (ARBs) used to treat high blood pressure and heart failure. July 2018 marked the first of a number of voluntary recalls by generic drug makers for several ARB products due to NDMA contamination thought to be the result of a manufacturing issue.

Litigation Over NDMA Cancer Link

As Zantac recalls mounted, lawsuits accused drug makers of failing to warn millions of unsuspecting consumers

that use of ranitidine could expose them to unsafe levels of NDMA. Unlike valsartan, plaintiffs claim, the high levels of NDMA produced by ranitidine are not the result of a manufacturing defect, but rather a problem inherent to the molecular structure of the drug itself. This, coupled with the excessive levels of NDMA detected in the product, created a particularly high safety risk for users. Hundreds of plaintiffs now

link their cancer diagnoses to ranitidine use. Separate federal MDLs for Zantac and Valsartan NDMA litigation have been created to manage these growing dockets.

What Comes Next

Recently, the FDA found elevated levels of NDMA in some extended release metformin products, prompting many to wonder if we've only seen the tip of the NDMA problem. As Thornton Law

Firm's Marnie McGoldrick notes, "due to lax FDA safety oversight and the fact that the majority of all medications in the USA are made overseas, these impurities likely exist in many other medications consumers take on a regular basis daily." Whether they exist in amounts large enough to cause injury, or to prompt litigation remains to be seen. But it is certainly something worth watching.

But we never rest on our laurels. We continue to utilize technology to improve our communication with both potential clients and our co-counsel firms. As a result of pandemic-related office closures, we made FTP (File Transfer Protocol) a standard method for providing signed case documents to co-counsel. This method provides co-counsel access to signed case documents 2-3 days sooner than mailing.
