he start of a new decade, 2020 was enthusiastically proclaimed "the year of clear vision and purpose." Pandemic Silver Linings

The decision to close our office weeks before the state's shelter in place order materialized was an easy one for Sokolove Law. We have spent the last decade upgrading our technology and automating our systems, which has not only sustained our firm as a leader in our industry, but also enabled our employees to access all the information they need to perform their respective jobs easily and securely from anywhere.

With the announcement of the closure on a Friday, we were completely operational on Monday morning. What we didn't foresee, however, was how we would quickly use this "new normal" to improve our operations. Thus, our pandemic silver linings came to light.

• Intake Screening — Our Case Management Team has been working remotely for more than three years. This team is spread across eight states, in all four time zones. Our call center is open 24/7.

- Client Communication Inbound and outbound calls are handled by the remote Case Management Team, and our automated printing process allows us to print letters and case paperwork remotely. We also utilize email communication with over 50% of our callers.
- Co-Counsel Communication Several co-counsel firms transitioned from sending checks, case updates and other case documents electronically via email rather than physical copies through the mail. (Thank you!)
- Case Sign-up —We have used digital document execution for 10+ years, and we have continued to expand our usage in 2020. Our digital document usage is up 11% since March, and nearly 25% of digital contracts are executed same-day.

We have utilized File Transfer Protocol (FTP) to securely send documents to our co-counsel firms for several years. We have expanded this process to include all co-counsel firms for which we do case sign-up.
