

Were You Exposed to Asbestos While Serving in the Military?

- Asbestos was used as fireproofing insulation and could be found in engine rooms, boiler rooms, galleys, mess decks, wardrooms, sleeping quarters and other areas throughout military vessels, including submarines. You may have been working directly with an asbestos-containing product, or you could have been exposed when disturbed asbestos dust traveled to other areas of your ship.
- While in the military, certain jobs or daily tasks could have put you at risk of being exposed to asbestos. Depending on your occupation, asbestos exposure may have continued outside of the military. Many different workers, like plumbers, auto mechanics, and construction laborers handled asbestos-containing products regularly.
