

Did Your Shipyard Job Expose You to Asbestos?



Prior to 1980, all types of ships were built using asbestos-containing products. At the time, asbestos was hailed for its fireproofing properties and was used to insulate pipes, gaskets, boilers, incinerators, valves, and other similar materials. Unfortunately, while asbestos was an important part of most shipyards, many workers may have been at risk of inhaling its tiny fibers — fibers that are known to cause mesothelioma, a deadly cancer.

- Because asbestos was so widely used in shipyards, anyone working in a shipyard could have been exposed. During construction or repairs, asbestos dust was often released into the air and anyone in the surrounding area would have been in danger of inhaling the asbestos fibers. In fact, 33% of mesothelioma cases involve U.S. Navy or shipyard exposure.
- Some shipyard workers may have brought asbestos dust home on their clothes and shoes or in their hair – unknowingly putting their family at risk of secondhand exposure to asbestos.
